As a public body, we are obliged to follow regulations governing the procurement of goods and services. World Trade Organisation (WTO) Rules set out detailed procedures for the award of contracts whose value equals or exceeds specific thresholds. As a public body, we are legally obliged to comply.

The most significant legislative requirement is the need to undertake Competitive Tendering.

Procurement is committed to ensuring that sustainability consideration is also given to each procurement we undertake to ensure that sustainability is embedded in the procurement process.

This page is designed to provide suppliers with information on becoming a supplier to Registers of Scotland.

Every year, we spend about £32M on goods and services and we want to make sure as many suppliers as possible can get a share of this spend.

We want to make it as simple as possible for you to do business with Registers of Scotland (RoS).

How to Do Business with Us and Current Contract Opportunities

The first step in supplying to us, and the wider Scottish public sector, is to register with the Public Contracts Scotland and Public Contract Scotland Tender websites.

Register your details on Public Contracts Scotland (PCS) we use this website as a main reference point when conducting market research.

Monitor Public Contracts Scotland and Find a Tender Service (FTS) regularly for any relevant tender opportunities.

To register your interest for taking part in any tender opportunity, follow the instruction in the PCS or FTS advertisement.

Public Contracts Scotland is a free and easy way to access details of all public sector contract opportunities in Scotland.

The portal enables suppliers to gain access to a wide range of contract opportunities free of charge.

To make sure your bid is considered, you must:

- Provide all the information asked.
- Answer all questions accurately.
- Provide a response in the requested format.
- Return the documentation by the specified closing date.

Returned tenders will be assessed against the evaluation criteria. Evaluation will focus on how the tenderer proposes to deliver the service or goods in relation to cost, service and quality. The balance between quality and price will be decided by the service or goods to be obtained.

In most cases, contracts will be awarded based on the most economically advantageous offer received.

Procurement Journey

RoS have adopted full use of "The Procurement Journey" developed by Scottish Government.

The Procurement Journey is intended to support all levels of procurement activities and to help manage the expectations of stakeholders, customers, and suppliers alike. It helps best practice and consistency across the public sector.

There are simplified processes, templates, and guidance to support individuals with authority to obtain lower value, lower risk procurements. This provides one source of documentation nationally which can be updated on a continual basis with any changes in legislation, policy, and promotion of best practice.

RoS now use the source documentation in the Procurement Journey for every procurement exercise to ensure the most recent guidance and templates is used. There is also detailed information on Sustainability.
